- 2. Will also review and recommend appropriate strategies for effective resource mobilization efforts and their impact on rural dwellers as promulgated by the government development agenda.
- 3. Lead/initiate professional consultations, identify, and analyze key sector trends, market dynamics including those of the energy and concession/natural resource sector laws and regulations, and work with a core team to advise the Government of Liberia accordingly on specific investment priorities.
- 4. Critically assess the concession/natural resource sector revenue generation impacts on the national budget to determine if it's people-centered and recommend doable measures to ensure effectiveness in resource tracking.
- 5. Ensure development of a harmonized policy framework/plan on Liberia's natural resource, energy and concession sectors.

- 6. Provide professional inputs in the GC's collaborative work with other professional bodies, reform institutions and governance entities, civil society organizations (CSOs), private sector and international partners.
- 7. Work with the GC's team and provide substantive inputs during preparation of annual work plan for the EGU based on the Commission's 5 five year strategic plan.
- 8. Prepare inception and end of consulting service reports covering tasks.
- 9. Perform other specific professional/technical tasks including to build the capacity of other professional staff in the employ of GC through knowledge transfer and skills building as deemed necessary by immediate supervisor and the Commission.

- Must possess solid understanding of Liberia's economic-governance system with emphasis on revenue generation and management, the energy and concession/natural resource sectors
- Must possess strong policy analysis, policy options and implementation strategies skills in economic governance related issues i.e., rationalizing and harmonizing challenges and impacts of revenue generation on national budget, the energy and concession/natural resource sectors
- Must possess good interpersonal skills and willingness to work longer hours at times under extreme circumstances with stakeholders from diverse background, irrespective of political, ethnic, religious, cultural affiliations
- Must have worked in a post-conflict environment i.e., in Sub-Sahara Africa
- Must be computer literate in MS Word, MS Excel, PowerPoint Presentation, etc.
- Must be fluent in written and spoken English
- A clear understanding of African Development Bank and World Bank processes and procedures will be an added advantage.
