Purpose: The Expenditure Management Division, headed by an Assistant Minister, is responsible for overseeing the expenditure and financial management systems for GOL. The Division is also responsible for reviewing, revising, producing and overseeing the implementation of GOL financial laws, regulations and procedures. The Division advises the MAs of their core, contingent and supplementary budget approvals. It also monitors and analyses MAs expenditure and proposes improvements thereof. The Division additionally coordinates cash management. The Division has three Units: Financial Approval; Financial Regulation; and Expenditure Monitoring.

The Financial Regulation Unit, headed by the Director Financial Regulation, is responsible for overseeing the formulation, dissemination and implementation of government financial laws, regulations and procedures. The Unit works closely with the CAG in enforcing and identifying weaknesses in the laws, regulations and procedures and proposes amendments. It also deals with reforms relating to expenditure as recommended by the PFM Coordination Unit. The Assistant Director provides technical oversight of the unit.
